### REPORT ON THE COLLECTION OF ASSESSED CONTRIBUTIONS

- 1. The Director has the honor to present a report on the status of assessed contributions due from Member, Participating and Associate States as of 31 December 2013 and 30 April 2014, respectively.
- 2. Total assessed contributions due as of 1 January 2013 was US\$ 134,277,423,<sup>1</sup> of which \$95,565,748 were received during 2013, resulting in a balance of \$38,711,675 on 31 December 2013. These pending contributions are comprised of \$36,545,911 for 2013 assessments and \$2,165,764 for prior year assessments. The status of assessed contributions as of 31 December 2013 and detailed information on the payments by Member State and by payment date are included in Annex A.
- 3. In order to provide the Executive Committee with more recent information, an updated table on the status of assessed contributions as of 30 April 2014 is attached as Annex B. This table indicates that total assessed contributions due on 1 January 2014 were \$144,331,675, of which \$57,134,650 were received as of 30 April 2014. The balance of assessed contributions due is \$87,197,025.
- 4. The Organization continues to encourage the Member States to make prompt payment of their outstanding assessed contributions. As of 30 April 2014, no Member State is in arrears such that it can be subject to Article 6.B of the PAHO Constitution.

### **Action by the Executive Committee**

5. In consideration of this report, the Executive Committee may wish to consider the proposed draft resolution found in Annex C.
