1. Introduction

Tobacco use is a major preventable cause of premature death and disease worldwide. Approximately 5.4 million people die each year due to tobacco-related illnesses -- a figure expected to increase to more than eight million a year by 2030. If current trends continue, tobacco use may kill a billion people by the end of this century. It is estimated that more than three quarters of these deaths will be in low- and middle-income countries¹. An efficient and systematic surveillance mechanism is essential to monitor and manage the epidemic.

The Global Tobacco Surveillance System (GTSS) is a set of globally standardized surveys to monitor tobacco use and key tobacco control policies. It is comprised of both youth and adult surveys. Launched in 1999, the Global Youth Tobacco Survey (GYTS) is a global standard for systematically monitoring youth tobacco use (smoking and smokeless) and tracking key tobacco control indicators. GYTS assists countries to enhance their capacity to design, implement, and evaluate tobacco control interventions. It is an important tool to assist countries in supporting WHO MPOWER, a package of six evidence-based demand reduction measures contained in the WHO's Framework Convention on Tobacco Control (FCTC).

GYTS is one of the largest public health surveillance systems, and it has been active in more than 188 countries/sites. The survey is repeated every 4-5 years generating data that are comparable within and across countries.

1.1 Overview of the Global Youth Tobacco Survey

GYTS is a nationally representative school-based survey of students in grades associated with 13 to 15 years of age and is designed to produce cross-sectional estimates for each country. It uses a global standardized methodology that includes a two-stage sample design with schools selected with a probability proportional to enrollment size. The classes² within selected schools are chosen randomly and all students in selected classes are eligible to participate in the survey. The survey uses a standard core questionnaire with a set of optional questions that permits adaptation to meet the needs of the country on tobacco use and key tobacco control indicators. The questionnaire consists of the following topics: tobacco use (smoking and smokeless), cessation, secondhand smoke (SHS), pro- and anti-tobacco media and advertising, access and availability to obtain tobacco products, and knowledge and attitudes regarding tobacco. The questionnaire is self-administered; using scannable paper-based bubble sheets, it is anonymous to ensure confidentiality.

As a companion to GYTS, the seven-question School Policy questionnaire was developed to collect information about school policies related to tobacco use among staff and students. This self-administered questionnaire is completed by one of the school administrators.

To maximize the efficiency of the data collected from GYTS, a series of manuals has been created. These manuals are designed to provide countries with standard requirements as well as

recommendations on the design and implementation of the survey at every step of the GYTS process. They are also designed to offer guidance on how a particular country might adjust features of the GYTS protocol to maximize the utility of the data within the country. Following the standard protocol and procedures in these manuals is strongly encouraged to maintain consistency and comparability across countries and for the successful implementation of GYTS.

1.2 Use of this Manual

This document aims to provide practical, step-by-step, and easy-to-follow instructions to implement GYTS and is classified into three broad categories:

- **Country Engagement Process:** Includes country commitment and engagement, implementing agency selection, and research coordinator nomination.
- **Protocol Adaptation:** Adaptation and finalization of the questionnaire, sample design, proposal development, and fieldworker selection and training.
- **Field Implementation:** Contacting and scheduling schools, preparing materials for survey administration, administering the survey, documenting school and class participation, and returning header and answer sheets.

1.3 Introduction to the GYTS Process

The GYTS process is systematic and standardized and is described in the **GYTS Process Chart** on the following page. The collaborating organizations are the United States Centers for Disease Control and Prevention (CDC) and the World Health Organization (WHO).

2. Country Engagement Process

The country engagement process is comprised of the following steps:

- 1. Letter of engagement to the Ministry of Health (MoH) and country commitment.
- 2. Implementing Agency (IA) selection.
- 3. Nomination of the Research Coordinator (RC).
- 4. Obtaining the list of schools with grades associated with ages 13-15 years.

2.1 Country Engagement

The WHO Regional Office (RO) will initiate the country engagement process with the participating country. An official memo or letter will be addressed to the Ministry of Health (MoH) and/or the Ministry of Education (MoE) requesting nomination of the IA and the RC. Examples of an introductory letter and a letter of support are provided in **Appendix A**.

2.2 Implementing Agency (IA) Selection

It is important for participating countries to select an agency to be in charge of the ongoing and systematic data collection. Since GYTS is a school-based survey, the MoH may collaborate with the MoE in identifying and nominating the IA.

The following are suggested selection criteria:

- Capacity to implement school based surveys at a national level. Agencies such as the MoE, MoH, academic institutions, and National Statistical Offices are ideally suitable.
- Previous experience with implementation of GTSS surveys.
- Interest and availability.
- Capacity to manage timelines.
- Collaboration with MoH and MoE.

The MoH is responsible to select an appropriate IA for implementing GYTS within the country.

2.3 Nomination of the Research Coordinator (RC)

The RC represents the IA and is responsible for the entire survey implementation including data collection, analysis, publication, and data dissemination. The terms of reference for the RC are outlined in the contract issued by the WHO RO and agreed upon by MoH described in **Section 3.4.1**.

The following criteria of selection are recommendations for the RC selection:

 Capacity and previous experience in overseeing surveys; including training of field-workers on standard survey procedures, managing survey logistics and field-work coordination, previous experience with school-based surveys or GTSS surveys, and publication and dissemination of findings from these surveys.

- Availability to participate in all GYTS workshops.
- Experience in working with both the MoH and MoE.
- Experience and familiarity in collaborating with the country's national tobacco control program/unit.
- Knowledge of the English language as the workshops are conducted in English. Should also have English language writing skills and experience in reporting and presenting survey results.
- Knowledge of epidemiology and basic statistics.
- Knowledge of public health with special emphasis on issues related to tobacco control and different types of tobacco use in the country.

2.4 Obtaining School Enrollment List

Obtaining school enrollment is an integral part of the engagement process that should occur prior to the RC attending the training workshop. The process for obtaining school enrollment is discussed in-depth in **Chapter 3** (Section 3.2.2).

3. Protocol Adaptation

Protocol adaptation starts at the training workshop. However, the RC has to prepare and obtain some information necessary for discussions during the workshop. This includes reviewing the core questionnaire and optional questions for adaptations, providing information on the sampling parameters worksheet, and obtaining a school enrollment list from a respective official agency. This information is important for effective utilization of time and discussions. The purpose of the training workshop is to orient the RC to the tasks and materials related to implementation of GYTS. The primary tasks of the workshop are to review and adapt the questionnaire, review and finalize the sampling parameters worksheet and enrollment list, and develop the proposal and budget for the implementation of GYTS. It is important that the Sampling Parameters Worksheet (Appendix B) and the GYTS School Enrollment List (Appendix C) be provided to CDC prior to the training workshop to assure that the sample can be finalized at the training workshop.

3.1 Questionnaire Adaptation: Process, Guidelines and Finalization

The *GYTS Core Questionnaire with Optional Questions* includes the Global Core questionnaire, optional modules and questions, and the School Policy questionnaire. This section provides information on adapting and finalizing the GYTS questionnaire for country-specific use, including an overview of the questionnaire adaptation and review process, translation, guidelines for adaptation, and pretesting and finalization.

The chart provided on the next page lists the specific tasks involved in the questionnaire adaptation and review process. The adapted GYTS country questionnaire should be sent to the WHO RO and CDC for review. The WHO RO and CDC will work with the country to finalize the questionnaire. (Note that no changes need to be made to the School Policy questionnaire. The only development tasks related to the School Policy questionnaire are translation and back-translation.)

Notes:

- If a GYTS country will be using the same exact questionnaire (no changes or new questions added) that has been fielded in a previous GYTS, there will be no need for review, translation/backtranslation, and pretesting.
 - If there are minimal changes from a previous GYTS implementation, the country should discuss with WHO RO and CDC to determine the appropriate process.
- The process is strictly confidential and at any stage the questionnaire, in part or full, should not be disclosed or shared with any other members or persons outside the WHO RO and the CDC without the prior approval/permission from the IA [RC].
- Edits to questionnaires and supporting documents in the above process should be done using track changes.
- The cover page of the GYTS questionnaire and the School Policy questionnaire and the file names should all include the date on which the questionnaire was updated to ensure strict version control.

3.1.1 Guidelines for Questionnaire Adaptations

The GYTS Global Core questionnaire should be used by all GYTS participating countries. The following steps should be followed for adapting the questionnaire for country-specific use:

- Start with the GYTS Global Core questionnaire, which includes 43 questions (C1 through C43). All of these questions should be included in the country-adapted questionnaire and they should not be altered (except for when there are instructions to do so).
 - Note that C24 can be removed if the country has a comprehensive national law in place that bans smoking inside all enclosed public places.
- 2. Fill in country-specific examples and response categories for the specified core questions.
 - Includes the following: examples in the Introduction, C3, C4, C9, C10, C13, C14, C20, C21, C24, C25, C26, C28, C29, C35.
- Add the optional questionnaire modules, if appropriate. There are three optional modules: smokeless tobacco, bidi, shisha (waterpipe). Modules should be placed after the Global Core questions.
- 4. Add questions from the list of optional questions, if appropriate. There are optional questions for each of the Global Core topic areas: background characteristics, tobacco use, cessation, secondhand smoke, economics, media: anti-tobacco, media: pro-tobacco, and knowledge, attitudes, & perceptions. The optional questions should be placed in their respective topic area section in the Global Core.
 - Note that many optional questions are specific for tobacco smoking or for cigarettes. These
 optional questions can be altered for other tobacco products (e.g., smokeless tobacco) if
 needed.
- 5. Additional questions ("country-specific") not included in the GYTS Global Core or list of optional questions can be included if needed to address important country-specific issues. Country-specific questions should be appropriately justified for inclusion.
- 6. Once the country questionnaire is finalized, it will need to be translated into the local country language. In addition, after it is translated into the local country language, it will need to be back-translated into English. The same process is required for the School Policy questionnaire.
 - Translations and back translations of questionnaires should be done independently by language experts. Content and survey experts should review the translations for appropriateness.

Additional guidelines to follow during the questionnaire adaptation process:

- Length of questionnaire: The suggested maximum number of total questions to include in a GYTS country questionnaire is 75.
 - When adding optional and/or country-specific questions to the Global Core, keep in mind that as the length of the survey increases, the potential for respondent fatigue may increase which might result in reduced data quality (e.g., missing answers, satisficing).
 - Selected optional and country-specific questions should be deemed as important for a country and the utility of these questions should be demonstrated.

- Question Numbering: The GYTS Global Core, optional modules, and optional questions have standard numbering schemes (e.g., C1-C43 for the Global Core, S1-S14 for the shisha module). The purpose of these standard numbering schemes is for ease of tracking at the analysis stage.
 - o During the questionnaire adaptation process, the standard numbering should be kept.
 - Once the content of a GYTS country questionnaire has been finalized, the questions should be renumbered "1" through "XX" for the final version.

3.1.2 Questionnaire Pretesting and Finalization

The adapted GYTS country questionnaire is recommended to be pretested in-country before full field implementation. Below are general guidelines for conducting this activity:

- Objectives: 1) Evaluate the translated wording of the Global Core questions and selected optional questions, 2) Evaluate the comprehension and translation of any country-specific questions, 3) Evaluate the overall flow of the country questionnaire, including the placement of optional and/or country-specific questions.
- Participants: 13 to 15 year old students
- Number of Participants: 6 to 8
- Procedures:
 - Pretesting can occur at any designated location (school, youth center, meeting room, etc.).
 - Questionnaire should be administered in a group setting using the GYTS standard protocol with a facilitator. Participants will be instructed to complete the GYTS questionnaire on their own.
 - After completion of questionnaire, the facilitator will conduct a group debriefing session. Participants should discuss any confusing questions and wording. Further information on this is provided below in suggested probes for debriefing.
- Instructions to the Participants:
 - Purpose of the survey is to make sure the survey questions are "good" questions.
 - o There is no right or wrong answers and we will not be judging your answers.
 - All information is confidential and anything we discuss will not be shared with your parents or others.
 - We just want to get your thoughts and opinions of the questions: how difficult or easy it is to provide answers, how you came up with your answers.
 - It is okay if you have difficulties with the questions that is the information we are looking for.
 Also, it is okay if you have no difficulties and you think the questions are easy to answer.
 - First, you will complete the survey on your own and then we will discuss the survey questions as a group.
 - While you are completing the survey, if you have a problem or question about any of the questions, circle the question and write any notes down next to the question. You can then discuss this during the debriefing.
- Suggested Probes for Debriefing:
 - General debriefing:
 - Which questions were difficult to answer? (Why?)

- Which questions or specific words did you not understand? (Why?)
- Do you think the questionnaire was too long, too short, or an okay length? (Why?)
- Specific probes for individual questions:
 - In your own words, what is this question asking?
 - How did you come up with your answer to this question?
 - How easy or difficult was it for you to answer this question? Why?
 - How well does this question apply to your situation?
 - In your own words, what does this question mean to you?
 - How did you decide what to answer?
 - How confident are you in your answer?
 - Are these answer choices okay or would you have liked to answer differently?

3.2 Sample Design Development: Process and Procedures

This section provides information on the sample design development process including procedures for school and class selection, completing the sampling parameters worksheet and school enrollment list, and completing the school and class-level sample information forms. The WHO RO and CDC will work together with the country IA [RC] to finalize the sample design. The chart below provides a listing of the specific tasks involved in sample design development.

GYTS Sample Design Development Process

Notes:

- The process is strictly confidential and at any stage the sample design, in part or full, should not be disclosed without the prior approval/permission from the IA [RC] and CDC.
- Communication between IA [RC] and CDC should be copied to the WHO RO.
- Titles of documents should consist of the date in which they were created to ensure version control.

3.2.1 Procedures of School and Class Selection

GYTS consists of a two stage design with schools selected randomly (systematically) at the first stage using probability proportional to the school enrollment size, followed by classes chosen randomly (systematically) within selected schools; then all students within a selected class are eligible to participate in the survey. The target student population for GYTS, and thus the sample frame, should include both public and private schools, and grades or classes that represent the student population of boys and girls of 13-15 years of age who are enrolled in schools located in the included areas of the country. All schools, irrespective of their level (e.g., primary, middle, secondary, high), should be included in the sample frame, unless the schools do not consist of grades/classes that represent students aged 13-15 years.

Certain countries coordinate GYTS with other surveys (e.g., the Global School-based Student Health Survey (GSHS)). The coordination is typically done by sampling twice the number of classrooms to produce two non-overlapping samples of classes or a 'double draw' of classes. Further information on how to select classes using a 'double draw' is provided in the *GYTS Sample Design and Weights* manual.

3.2.2 Completing Sampling Parameters Worksheet and School Enrollment List

As indicated in the sample design process overview, completing the sampling parameters worksheet based on the sample selection requirements of the country is important for sample selection. A country RC is required to provide information on the target population and other sampling parameters to select the schools and subsequently the classes. **Appendix B** describes the information needed on sampling parameters to ensure the representativeness and standards of the selected sample.

A school enrollment list is a list of students by each grade in a school or a list of number of students in a school by grade and sex (e.g., a list of students in a region/country). Sometimes, the complete list of schools in a country may need to be obtained from various sources (e.g., individual lists of secondary schools, middle schools and high schools, list of schools by regions of the country, or lists of schools by school type (private or public)) and pooled or compiled to make a final nationally representative list of eligible schools. The key information needed for each school on this frame, at a minimum, should include all eligible schools in a country and consist of a unique school ID, school name, location or contact information (address), school type (private/public), and the school enrollment size of eligible grades/students by grade and sex. Please refer to **Appendix C** for more information on the school enrollment list.

3.2.3 Completing School and Class-Level Sample Information Forms

The school selection list and the school and class-level sample information forms are provided to the RC for class selection and data collection. Based on the class list in each eligible school, classes are randomly selected using the random numbers on the school-level form. After completion of class selections and fieldwork implementation, completing the school and class-level sample information forms accurately is crucial for monitoring data collection, sample weighting, and data analysis. Refer to **Appendix D** for the school selection list, **Appendix E** for an example of how to select classes based on the school-level sample information form, **Appendix F** and **Appendix G** for properly completing the school and class-level sample information forms, and **Appendix H** for properly completing the class header sheet.

3.3 Proposal Development

Proposal development is an important step in preparing to implement GYTS in a country. The proposal should include the following details related to the tasks of implementing GYTS including timeline, staffing, and budget details:

- Proposal cover sheet: Include contact information, principal investigator or RC, and proposed period during which the survey will be implemented.
- Overview of country history and the need for conducting GYTS: Include a brief description on the state of tobacco surveillance, policy development, and control. Explain why it is important to implement GYTS in your country and how you plan on using the results. Include a brief overview of a previous GYTS (if it exists) and how the results were used.
- Implementation plan: Outline the steps for survey implementation. Provide detailed information about when the survey will be conducted with justification (expected fieldwork/data collection period), and highlight any existing gaps and challenges and plans to overcome them. Provide a detailed timeline of how long the GYTS implementation is expected to take from start to finish.
- Budget: Provide a detailed budget in US dollars (USD). Brief justification, quantity, unit price, and total cost are required. The justification for each item requested in the budget should provide sufficient detail to explain need and relevance to the survey. All requested budget items will be evaluated for reasonableness. An example budget is available in **Appendix I**, and a template is available electronically upon request.
- Attachments: Include a list of other potential sources of support (if any), letter(s) of support from MoH/ MoE, and adapted questionnaire.

The proposal should be no longer than five pages, but a shorter length is preferred. Attachments are excluded from the proposal page limit.

3.4 Research Coordinator and Fieldworkers Responsibilities

Any survey implementation is a coordinated effort, and collaboration among a number of agencies in the country (i.e., the MoH, MoE, and other agencies) is essential for success. This coordinated effort will enhance levels of participation by schools and be especially helpful for supporting the RC and recruiting fieldworkers.

3.4.1 Responsibilities of the Research Coordinator (RC)

The RC is responsible for the overall management of the survey and functions as a liaison between other agencies or departments in the country, the WHO RO, and CDC. The RC is responsible for coordinating the development of the final GYTS questionnaire for the country. In addition, the RC is responsible for making the initial contact with the schools selected to participate in the survey and will work to secure the participation of the selected schools. Finally, the RC will also be responsible for producing the country report from the GYTS data in collaboration with the partner agencies.

The following are specific management responsibilities of the RC:

- Identify and assign fieldworkers for each selected school, as needed
- Develop a timeline for completing the fieldwork
- Daily communication with fieldworkers
- Ordering supplies
- Mailing materials to fieldworkers
- Managing the completed survey forms

The RC is also responsible for training fieldworkers. Fieldworkers can be trained most efficiently at the same time in a central location of your country. The purpose of the training is to ensure that all fieldworkers have the same information about GYTS and follow the same survey implementation procedures. The training session should be held shortly before the survey will be administered. A half-day or one-day session will be sufficient. A training agenda and relevant materials should be prepared. The agenda may include the following topics:

- Purpose of GYTS
- Confidentiality
- Scheduling survey administration
- Documenting school and class participation
- Completing school and class-level sample information forms
- Presenting and administering GYTS to the students
- Materials needed for survey administration

Sufficient time should be allotted for fieldworkers to ask questions and complete practice exercises or role-play. Emphasize the importance of maintaining the survey administration procedures and carefully completing all documentation.

3.4.2 Responsibilities of the Fieldworkers

Fieldworkers are assigned to specific schools and are responsible for the delivery and collection of all survey documentation forms, answer sheets, header sheets, and questionnaires. The fieldworkers' familiarity with the selected schools where they will be working is advantageous for an efficient survey administration. It is recommended to consider University students, MoH staff, or MoE staff as fieldworkers to administer GYTS.

4. Fieldwork Implementation

This chapter provides instructions on activities to assure that the IA [RC] is ready to implement GYTS. It includes information on obtaining school participation and class participation. This chapter also provides information on the materials required for survey administration, the data collection process, and how to properly return the completed survey materials.

The RC must complete the following tasks before the fieldwork implementation:

- Attend training workshop
- Proposal created and accepted
- Questionnaire finalized, translated and back-translated
- Sample selection completed and school and class-level sample information forms received
- Fieldworkers selected and trained
- School consent for participation received

4.1 Obtaining School Participation

Obtaining school participation may include contacting authorities from the MoE and MoH in addition to contacting the selected schools. Also you may be asked to make presentations to persons or groups responsible for granting approvals. In these presentations, you will describe the purpose of GYTS, show a copy of the questionnaire, and discuss the survey administration procedures.

4.1.1 Contacting Schools

The RC will contact the sampled schools and any local authorities that may be helpful throughout the survey process (e.g. school boards, or other relevant groups). For initial contact, a packet should be sent to the administrator, counsellor, or health education coordinator of each school with the following items:

- A copy of the letter of support from the MoE/MoH explaining the purpose and importance of GYTS.
- The finalized version of the country-specific GYTS questionnaire and School Policy questionnaire. At this stage, the questionnaires should already be translated into the country-specific language and approved by both the WHO RO and CDC.
- GYTS Questions and Answers (**Appendix J**) to act as a guide for school officials in response to questions from parents regarding the survey.

Follow-up contact with the schools should then be made to do the following:

- Confirm with the administrator in charge of making decisions for the school whether or not the school agrees to participate in GYTS and s/he agrees to complete the School Policy questionnaire.
 - All attempts should be made to have the principal or headmaster of each school complete the School Policy questionnaire. In extenuating circumstances (e.g., principal/headmaster on

leave, or ill during GYTS administration, etc.), other acceptable alternatives are another school administrator (e.g., vice-principal, etc.), the school nurse, or a teacher who is very familiar with the school's policies on tobacco use on and around campus for both students and staff. **NOTE: There should only be one School Policy questionnaire per school**.

- Determine a date and time to conduct the survey. Be flexible in working with the school in order to
 meet their scheduling needs. Verify that each of the selected classes will be available on the
 scheduled survey administration date. For example, you do not want to schedule the survey
 on a day that several classes will be on a field trip or taking exams.
- Establish minimally disruptive procedures so the survey can be completed by the students in a timely manner.
- Determine who at the school will be a focal point/contact person.
- Arrange to deliver parent notification forms (**Appendix K**). Parent notification forms should go out 3-4 days prior to administration of the survey. The school can distribute the forms to students in the selected classes to deliver to their parents, or they may mail them directly to the students' parents. Make sure the school has enough forms so that all parents of selected students receive a copy. Passive consent is used for GYTS.

4.2 Documenting School and Class Participation

When the GYTS school sample is drawn, at least two forms will be produced for each selected school -the school-level sample information form and the class-level sample information form. These two forms provide the necessary identification information for the fieldworker.

- The school-level sample information form (Appendix F), a two-page form, show the coordinating agency, the school name, the sample information (year, country, region and/or specific population), and the GYTS school ID. This pre-existing information will be auto-generated on the form. On the first page, the grades (forms, levels, secondary(s), or standard) that are taught in the school and the grades (form, level, secondary(s), or standard) that will be surveyed in the school will be filled in by the fieldworker as well as the total number of eligible classes. A list of random numbers, auto-generated by the sampling software, will be used for class selection, and will appear just above the class tracking information. In addition, on the bottom of the first page, there is a check box indicating whether the School Policy questionnaire was completed and an area to explain the reason if this questionnaire was not completed. On the second page, the class tracking information will be fieldworker. This contains a grid which is used to catalogue the completion status of each selected class.
- The class-level sample information form (Appendix G), a one-page form, also shows the coordinating agency (district), the school name, the sample information (year, country, region and/or specific population), and the GYTS school ID. This pre-existing information will be autogenerated on the form. A class-level sample information form must be completed for each class participating in a selected school. One copy of the class-level sample information form is provided. Additional copies must be made if more than one class is selected.
 - When filling out the class-level sample information form, the fieldworker will enter **the class ID**, **the number of students who are enrolled in the class, and the number of students who actually participated in the survey**. All students in the selected classes are eligible for participation.

In addition, one header sheet (**Appendix H)** must be completed for each participating class in each school showing the GYTS school ID (from the school-level sample information form) and the class ID (from the class-level sample information form).

4.3 Selecting Dates for Survey Administration

The dates selected for survey administration can affect school and student response rates. Remember the following guidelines as you select your survey administration dates:

- Avoid busy school schedules that decrease attendance.
- Avoid holidays, special conference days, field-trip days, and standardized testing days.
- Avoid administering the survey on the following days because attendance may be unusually low:
 - o The days right before or after school holidays
 - o Thursday and Friday in some countries
 - Monday or Friday in urban schools (in some countries)

4.4 Survey Materials

The fieldworker must have the following materials:

- Instructions for fieldworkers
- Script for fieldworkers
- One large envelope in which students can put their completed answer sheets
- A sharpened #2 pencil for each selected student
- Class tracking information
- School and class-level sample information forms with IDs
- A header sheet for each selected class in each selected school
- A GYTS questionnaire and answer sheet for each student
- One copy of the School Policy questionnaire and answer sheet marked with the GYTS school ID
- A pre-addressed, postage-paid return envelope

4.5 Survey Administration and Data Collection

The instructions for fieldworkers provide detailed information about the procedures to be followed prior to the survey administration, during survey administration, and after survey administration. A script is provided for fieldworkers (**Appendix L**) to read to the students who are participating in the survey.

4.5.1 Instructions for Fieldworkers before Going to a School

• Make sure appropriate school personnel (including teachers) are aware you are coming, when you will be there, and which classes (sections) you will be working with.

- Make sure that a school administrator (preferably the headmaster/principal) is willing to complete the School Policy questionnaire.
- Make sure you have the following materials:
 - A copy of the script for fieldworkers to be read to selected students (Appendix L).
 - One large envelope in which the students can put their completed answer sheets. You will need one envelope for each class.
 - A copy of the school-level sample information form containing the class tracking information for each school (**Appendix F**).
 - A copy of the class-level sample information form (**Appendix G**) and the class header sheet (**Appendix H**) for each class.
 - o Enough copies of the GYTS questionnaires and answer sheets for all selected students.
 - One copy of the School Policy questionnaire and an answer sheet marked with the GYTS school ID in the lower right hand corner of the sheet outside of the bubble area to provide to the school administrator. This step is very important; please assure that the GYTS school ID is on the School Policy questionnaire answer sheet to ensure that it can be properly linked to the GYTS data from the school.
 - Enough sharpened #2 pencils for the selected students. Let the students keep the pencils after they complete the questionnaire, if possible.

4.5.2 Administering the Survey in a Class

- Record on the class-level sample information form the number of students who are listed in the class.
- Fill out a header sheet for the class. The GYTS school ID and class ID must correspond to those listed on the class-level sample information form.
- Take attendance to be sure only the students selected to take the survey are in the room.
- Move students' desks throughout the classroom to minimize the chance students will see each other's' responses.
- Read the script for fieldworkers (**Appendix L**) and the instructions and introduction pages from the GYTS questionnaire (**Appendix M**) to the students before they begin. Remind students about the importance of the survey, that completing the survey is voluntary, that no one in the school will see their answer sheets, and that their grades in the class will not be affected by whether or not they complete the survey.
- Some students may have difficulty reading the survey. Establish a procedure for dealing with these students to avoid embarrassment and assure privacy.
- Do not allow students or teachers to wander around the room or talk while others are completing the survey.
- Remind students not to place their name or school name on the questionnaire or answer sheet.
- Allow enough time for students to complete the survey without feeling rushed. About 30 minutes should be sufficient.

- Before the survey begins, emphasize that only #2 pencils are used and make sure that there is a clear understanding on how to fill the bubbles correctly. (See Appendix N for answer sheet examples.)
- Do not review the answers to the survey as answer sheets are returned, even if this means accepting incomplete data. Do not even appear to look at the answer sheets. Students must be confident that their privacy is being maintained and their participation will remain unknown.
- When all students have returned their answer sheets, record on the class-level sample information form the number of students in the class who have completed the survey. Compare the number of completed answer sheets to the information on the class-level sample information form. Resolve any inconsistencies.

4.5.3 Administering the School Policy Questionnaire:

- Present the principal or headmaster with the School Policy questionnaire and answer sheet that has already been marked with the GYTS school ID in the lower right corner outside of the bubble area. **NOTE: There should only be one School Policy questionnaire per school.**
- Ask the principal or headmaster to complete the survey. Ask if you can return within a specific time frame (e.g., in an hour, at 3 pm, etc.) to pick up the survey. It is extremely important to pick up the School Policy questionnaire before you leave the school.

4.6 Mailing Completed Survey Materials

After completing survey administration, the following instructions should be followed to properly return the completed survey materials.

4.6.1 Instructions for Fieldworkers to Return the Completed Survey Materials

- Check the header and answer sheets for bubbles that have not been filled in completely (such as Xs, check marks, lines, circles, dots). Inform the RC of any incomplete bubbles.
- Bundle all the materials for each class together after the survey has been completed.
 - Begin with the class-level sample information form on top, then a header sheet followed by all the answer sheets from each class. Place these inside the envelope.
 - \circ $\;$ This procedure is to be followed for each class that participates in the survey.
- Stack the entire class envelope "bundles" for each school together after GYTS has been completed at a school.
- Place the completed School Policy questionnaire answer sheet and the school-level sample information form on top of all the class "bundles" for the school, and place all of the bundles together in a large envelope (or secured with a rubber band).
- Return or mail them to the RC.

4.6.2 Instructions for the RC to Return the Completed Survey Materials

After the RC has received the completed school-level sample information form, the class-level sample information forms, the header sheets, and the answer sheets from the fieldworkers, the next step is to

prepare the data for processing. Again, it is very important that each class is "bundled" and the classes are "stacked" together for each school.

Use the checklist provided in **Appendix O** to assure that all items necessary for analyzing the GYTS data are included, packaged, and shipped correctly. The processing steps are detailed below.

Review of Header Sheets and Answer Sheets

As school "stacks" are received from your fieldworkers, make sure they have been "bundled" carefully by class with a class-level sample information form, header sheet, and answer sheets. Check to see if the header sheet and the answer sheets can be scanned correctly for each class. Do not discard any answer sheets, and pay special attention to the following:

- Is there a header sheet and a class-level sample information form for each sampled class?
 - You must have a header sheet and a class-level sample information form for each class. Note: A class-level sample information form is also needed for selected classes that do not participate.
- Have the header sheets or the answer sheets been completed with a No. 2 pencil?
 - Review each header sheet and answer sheet to make sure it has been completed with a No. 2 pencil. If a lighter pencil has been used, color over the selected bubbles using a No. 2 pencil.
- Have the answer sheets been completed with anything other than a No. 2 pencil?
 - If ink or marker has been used, color over the selected bubbles using a No. 2 pencil. If answer sheets cannot be completed, just send back the sheets to CDC and DO NOT copy the responses to a new answer sheet.
- Are there stray marks on the answer sheets?
 - Check each answer sheet for stray marks and erase them completely. If they cannot be erased, just send back the sheets to CDC and DO NOT copy the responses to a new answer sheet.
- Are there any answer sheets that are folded or rumpled?
 - If the answer sheets are folded or rumpled, attempt to flatten them. If they cannot be flattened, just send back the sheets to CDC and DO NOT copy the responses to a new answer sheet.
- Have the header and answer sheet bubbles been filled in correctly?
 - Check the header and answer sheets for bubbles that have not been filled in completely (such as Xs, check marks, lines, circles, dots). Fill in any incomplete bubbles completely with a No. 2 pencil prior to sending to CDC.
- Has the GYTS school ID been written in the lower right hand corner of the School Policy questionnaire answer sheet?
 - Check the School Policy questionnaire answer sheets to assure that each one has been labelled in the lower right hand corner outside of the bubble area with the proper GYTS school ID for the associated school.

Assemble Header Sheets and Answer Sheets for Scanning

Arrange the header sheets and answer sheets neatly with the header sheet on top for each class. The class-level sample information form is then placed on top of the header sheet for each participating class. This comprises a class "bundle." Check to see that each sheet in each class "bundle" faces the same direction. Packaging in this way will make the data processing much easier. Place the class "bundle" in a separate envelope or use rubber bands to assure the "bundles" will remain intact. The school-level sample information form and the School Policy questionnaire answer sheet (with GYTS school ID in the lower right hand corner outside of the bubble area) should then be placed on top of all the class "bundles" for each selected school, placed inside the envelope, and tied securely. This comprises a school "stack" (See Appendix P.) Do not paste, glue, staple or tape the school-level sample information form to the envelope.

Sending Header Sheets and Answer Sheets for Scanning

Once the school "stacks" have been prepared they should be sent to CDC for scanning. Please include the following materials in your package:

- Copies of both the GYTS and School Policy questionnaires in the country's language AND the back-translated versions in English.
- School-level sample information form for each participating school and the answer sheet from the School Policy questionnaire placed on top of the class "bundles."
- A class-level sample information form for each sampled class with the appropriate header sheet and answer sheets for each class "bundle."
- Class tracking information filled out on the school-level sample information forms.
- The checkbox indicating whether or not the School Policy questionnaire was completed, and the reason why not should be completed on the first page of the school-level sample information form.

The package containing your school "stacks" (school-level sample information form and School Policy questionnaire answer sheet on top) of class "bundles" (class-level sample information form, header sheet, and GYTS answer sheets) should be sent to CDC (Global Tobacco Control Branch, Office on Smoking and Health). CDC will facilitate shipping of the materials. The RC should contact CDC to obtain mailing information. **NOTE: Do not include the parent notification forms in the package.**

Do not send your materials through the regular mail. All materials should be sent by a traceable method (e.g. FedEx, DHL) to minimize the possibility of all your efforts being lost in the mail. Please make sure that all materials are properly packaged in a box and taped securely to assure safety of the data during transport. Please keep a copy of all written documentation. (See **Appendix P** for shipping examples.)

Once your header sheets and answer sheets are scanned, CDC will send a file of your edited data along with an information sheet containing the layout of the file for your records.

5. Data Analysis and Reporting

Detailed information on data analysis and reporting can be found in the following GYTS materials: *GYTS Analysis and Reporting Package*, *GYTS Data Dissemination Guidance*, and *GYTS Data Release Policy*. The GTSS Data Coordinating Center will be responsible for working with GYTS countries on data analysis.

5.1 GTSS Data Coordinating Center

CDC serves as the Data Coordinating Center (DCC) and depository of GTSS data, including GYTS. The DCC provides data management, quality assurance, standardization, and data repository functions along with provisioning data sharing, release and dissemination. The DCC ensures the following:

- Individual countries can be assured their data will receive high quality support;
- As countries begin to repeat surveys, they will be assured that their analysis of trends will be grounded in strong and consistent statistical procedures and practices; and
- A coordinated process will enable standardized analysis which will be important to the direction and development of global tobacco control programs and policies.



GYTS Questions and Answers for School Officials

(To respond to questions from parents)

Q. What is GYTS?

A. The Global Youth Tobacco Survey (GYTS) is a nationally representative school-based survey that collects data on students aged 13–15 years using a standardized methodology for constructing the sample frame, selecting schools and classes, and processing data. The GYTS surveillance system is intended to enhance the capacity of countries to design, implement, and evaluate tobacco control and prevention programs

Q. Why is the survey being done?

A. The [name of agency] will use the survey results to help develop a comprehensive tobacco control program and policies. The survey results also will be used to develop school health programs designed to prevent and reduce tobacco use among students.

Q. Will student's names be used or linked to the survey?

A. No. The survey has been designed to protect each student's privacy. Students do not put their name on the questionnaire.

Q. How long does it take to fill out the survey?

A. One class/section period is all that is needed to fill out the written survey.

Q. Does the survey include a physical test?

A. The survey does not include a physical test or exam.

Q. What are the topics of the questions on the survey?

A. All questions on the survey relate to the students' attitudes, behaviors, and knowledge about tobacco use, intent to use, exposure to tobacco use, and exposure to tobacco marketing/advertising.

Q. How were the schools and students selected to be in the survey?

A. Appropriate statistical procedures were used to draw a representative sample of schools. Then classes are randomly selected in each participating school. All students in each selected class are eligible for participation. The survey will be repeated every 4-5 years to see the trends in tobacco use across time. Due to scientific sampling procedures, schools and classes that were selected in a past round may or may not be selected in the next round.

Q. Do students take the survey more than once to see how their behaviors change?

A. No. Students who take part cannot be tracked because their names are not on the survey.

Q. Is student participation anonymous? How is student privacy protected?

A. Survey administration procedures are designed to protect student privacy and allow for anonymous participation. Students submit an optically scannable answer sheet containing no personal identifiers, which are then placed in a large box or large envelope. Published reports do not include names of participating schools or students.

Q. Is this survey voluntary? What if schools or students do not choose to participate?

A. Participation in GYTS is voluntary. However, to develop accurate country estimates of tobacco use and intent to use tobacco among adolescents, participation rates must be high. Selected schools and students cannot be replaced. The goal is to achieve 90 to 95 percent participation by selected schools and students.

- Other questions may ask about <u>smoking tobacco</u> in general that includes cigarettes and other types of smoked tobacco products.
- Other questions may ask about using <u>smokeless tobacco</u>, which is tobacco that is not smoked, but is sniffed through the nose, held in the mouth, or chewed.
- Finally, other questions may ask about any <u>tobacco use</u> or any <u>tobacco products</u> this includes smoking cigarettes, smoking tobacco other than cigarettes, and using smokeless tobacco.



- Translation into the local country language and back-translation into English
- Renumber the final questionnaire from "1" through "XX"
- School Policy questionnaire (one per school)

- Sampling Parameters Worksheet
- School enrollment list (list of schools in a country AND number of students for each school by grade and sex, school name, location/address, school type [private/public])
- School-level sample information form (two pages, one for each school)
- Class-level sample information form (one page, one for each class)

PROPOSAL

- Cover sheet
- Country overview and need for conducting GYTS
- Implementation plan including detailed timeline
- Budget and budget justification
- Attachments (letters of support, adapted questionnaire)
- Maximum length is 5 pages, excluding attachments

SURVEY ADMINISTRATION AND DATA COLLECTION

- Script and instructions for fieldworkers
- School-level sample information form (one for each school)
- School Policy questionnaire and answer sheet (one for each school, include GYTS School ID)
- Class-level sample information form (one for each class)
- Header sheet (one for each class) with GYTS School ID and Class ID
- GYTS final questionnaires, answer sheets, and Number 2 pencils (one for each student)

- On page two of the school-level sample information form, fill in the class ID numbers and the names of the teachers
- On page two of the school-level sample information form, place a check mark in the corresponding section that the answer sheets and class-level forms have been received
- Print a Class-level sample information form for each class to be surveyed in each school
- Give a questionnaire, answer sheet, and Number 2 pencil to each student
- Place the answer sheets and corresponding class-level sample information forms in an envelope (one for each class). Then place these envelopes along with the school-level sample information form (both pages) in a larger envelope
- The school policy questionnaire should be answered by one person, preferably the head master or principal (if not available then the assistant, school nurse, or teacher)
- The answer sheet from the school policy questionnaire should have the GYTS School ID written on the bottom and placed in the large envelope with the school-level sample information form

IMPLEMENTATION DON'Ts

- Do not paste, glue, staple or tape any sample information forms, header sheets, or answer sheets to each other or to the envelopes
- Do not return the parent notification forms
- Do not return all copies of the GYTS questionnaire (return only one copy in the shipping package)
- Do not throw away any filled/completed answer sheets (return all filled/completed answer sheets to CDC)
