### How did we get here?

- September 2012 Road map approved by the 151<sup>st</sup> Executive Committee (EC)/Countries Consultative Group (CCG ) established
  February 2013 1<sup>st</sup> virtual meeting of the CCG
  - March Outline of documents approved by the 7<sup>th</sup> SPBA
- ✓ April 1<sup>st</sup> face-to-face meeting of the CCG: reviewed 1<sup>st</sup> draft documents and piloted the programmatic priorities stratification methodology
  - **June** Beginning of national consultations/1<sup>st</sup> draft of the documents presented to the 152<sup>nd</sup> EC
  - July End of national consultations/ 2<sup>nd</sup> face-to-face meeting of the CCG

# What are the main changes proposed in the new PAHO Strategic Plan?

- 1. Strategic vision with increased focus on health and well-being, universal health coverage, and social determinants of health
- 2. Explicit measurement of the reduction of inequity gaps in health
- 3. Joint commitment, responsibility and collaboration of all countries and territories of the Region, and the PASB
- 4. Programmatic priorities stratification framework
- 5. PASB leadership priorities to promote the regional public health agenda at all levels (political, strategic and technical)
