

### Regional Workshop on Deinstitutionalization in Latin America and the Caribbean

Date: October 8-9, 2019 Place: Bogotá, Colombia Meeting Room: Lunas

#### Introduction

The Mental Health and Substance Use Unit of the Pan American Health Organization (PAHO) has organized two meetings (Washington, DC, USA / December 2017 and Lima, Peru / September 2018) with the participation of experts and professionals with experience in reorganization processes of mental health services in diverse contexts. During these events, participants reviewed the situation of mental health services, identifying effective interventions for deinstitutionalization in Latin America and the Caribbean (LA&C).

Additionally, a literature review was conducted to identify best practices of deinstitutionalization and communitybased interventions as alternatives to the asylee model for people with severe, long-term mental disorders. In this initial phase, the review focused on the strategies used, as well as the facilitating factors and the main barriers.

Experience of deinstitutionalization in the region were evaluated and good practices identified through an online survey of mental health professionals and other actors with experience in the field.

Throughout this process, experiences and lessons learned were discussed, with a central focus on overcoming the old service model based on the psychiatric hospital and strengthening the fight against the stigma surrounding people with mental disorders. It was highlighted, among other aspects, that deinstitutionalization can only be developed in the context of a national mental health plan.

This workshop is part of the technical cooperation efforts that PAHO is developing with the countries of the Region to strengthen the reform of psychiatric services in Latin America and the Caribbean, considering that deinstitutionalization is an essential element in these processes.

### **Objectives:**

1. To review the current situation of mental health services in Latin America and the Caribbean, with emphasis on care for people with severe, long-term mental disorders.

2. To analyze the experiences and lessons learned in the deinstitutionalization processes of the Region.

3. To identify the road map for promoting and developing deinstitutionalization processes in countries, including the role of international technical cooperation.

### **Expected Results:**

- Inputs for the preparation of a technical document on deinstitutionalization in Latin America and the Caribbean, which will serve as a tool for countries to promote processes of this type.
- Identified the most effective international technical cooperation mechanisms in deinstitutionalization processes.
